Permanent Appointment of Temporary Educators serving continuously for 12 months or more

ELRC KZN Chamber: Collective Agreement No. 1 of 2006 – Permanent Appointment of Temporary Educators with 12 months or more of continuous service

1. PURPOSE:

To effect, within the approved post establishment, the permanent appointment of serving temporary educators who have been employed in the department for a period of 12 months or more on a continuous basis.

CONTINUOUS SERVICE means the current unbroken or broken service within the department as a CS educator provided that, in the case of broken service, such break in service was of 120 days or less.

2. SCOPE:

This agreement applies to and binds:

- 2.1 the KwaZulu-Natal Department of Education;
- 2.2 all educators employed by the KwaZulu-Natal Department of Education;
- 2.3 all employee parties that are parties to the KwaZulu-Natal Chamber of the Education Labour Relations Council; and
- 2.4 members of such employee parties

3. PARTIES TO THE CHAMBER NOTE:

- 3.1 The contents of the following ELRC Resolutions:
- 3.1.1 Resolution 4 of 2001 which provides for the permanent appointment of under-qualified temporary educators;
- 3.1.2 Resolution 5 of 2001 on the 'Appointment of Educators who are not Professionally Qualified'; and
- 3.1.3 Resolution 4 of 2002 which provides for the permanent appointment of unqualified temporary educators
- 3.2That since the withdrawal of ELRC Resolution 6 of 1998, many temporary educators who have been serving the department continuously for 12 months or more, were not appointed permanently despite posts being advertised:
- 3.3 That such temporary educators provide an invaluable service to the department in delivering the curriculum;
- 3.4That parties to Chamber acknowledge the need to effect the permanent appointment of temporary educators who have served the department for 12 months or more on a continuous basis in an effort to promote security of tenure of educators;
- 3.5 The employer's obligation to serving permanent educators who have been declared additional to their schools' post establishments:

- 3.6 The Employer's obligation to transfer serving permanent educators who have been declared in surplus in terms of operational requirements.
- 3.7 The provisions of the Employment of Educators Act 76, of 1998, as amended.

4. PARTIES TO THE CHAMBER THEREFORE AGREE THAT:

- 4.1 All permanent educators declared additional to the post establishment of their schools must first be accommodated in substantive vacant posts using applicable criteria;
- 4.2 Temporary educators who have served the department continuously for 12 months or more in one or more substantive post/s should be made permanent, subject to the recommendation of the School Governing Body;
- 4.3 A closed vacancy list of the remaining available posts should thereafter be compiled to accommodate the temporary educators who served the department continuously for a total combined period of 12 months or more in substantive and/or substitute posts; and,
- 4.4 The abovementioned temporary educators must meet the minimum requirement for appointment as set out in Chapter B 2 (2) of the Personnel Administration Measures (PAM).

5. DATE OF IMPLEMENTATION

This agreement shall be effective from the date it is ratified by the ELRC, in accordance with clause 6.2.4 of Annexure B of the constitution of the ELRC.

6. DISPUTE RESOLUTION

Any dispute arising from this agreement shall be referred to the Council for resolution in terms of its constitution.
